There are six (2) positions available on the Board of Directors beginning May 1, 2011. Any Active Member in good standing is eligible for nomination by another MAEMT member or self nomination. The time commitment during the year varies according to the board projects and commitments. However, all Board members are required to:

- Attend scheduled board meetings and Special meetings as deemed necessary. Regular board meetings are held the third Friday of every other month in Lansing at 10:00 a.m.
- Participate in conference calls and e-mail communications.
- Chair committees or participate on committees as deemed necessary and appropriate to conduct the business of MAEMT.
- Directors shall not be compensated for their services as a member of the board.

The Board of Directors has the supervision, control and direction of MAEMT affairs, committees, publications and financial stewardship and determines its policies and objectives. Members of the Board are expected to conduct MAEMT business in the best interest of MAEMT and the members.
